5. Strictly No Dogs allowed on the club grounds
6. Persons on the property should remain Alert particularly when the playing fields are in use
7. Children must be accompanied and supervised
8. Property Damage and Health and Safety concerns should be reported to insert contact
9. Smoking permitted in designated areas only
10. The following are not permitted:
 - Entry upon the playing field other than by players, team mentors and match officials
 - Throwing of objects onto the Playing Fields
 - Bringing of alcohol onto the club property
 - Behaving in an offensive or indecent manner
 - Bringing into the ground of fireworks, smoke cannisters, bottles, glasses, cans, flags, banners, poles, laser pointers and other similar articles or containers, including anything that may be used as a weapon
 - Excessive noise such as that from the use of radio sets or other appliances and behaviour likely to cause confusion or nuisance of any kind including foul or abusive language

Suggested Proposed Signage and location which will be determined by each club when completing Risk Assessment and adopting the Club H&S Statement

Sign 1. Standard Occupiers Liability Sign Fogra (Determine no of signs and location. For example 2 no: 1 at Main gate and no: 2 at Pedestrian gate)

Sign 2. Ground regulations (Determine no. of signs and locations. For example 2 no: 1 at pedestrian gate, no: 2 Double sided sign inside fence / gate at main car park access to pitch)

Sign 3. Exit signage and Emergency lighting

Review all exit routes & ensure signage in place

Sign 4. Fire extinguishers

Review location of FE and ensure signage in place

Sign 5. Fire Assembly Point

Review location and signage in place

Sign 6. Warning signs

Following H&S Risk assessment of property - signage should be put in place at identified areas.

E.G. - Electrical warnings where applicable (plant room), Unauthorised entry signage in relevant areas, Fire warning at Oil tank, Warnings where cleaning or garden products may be stored, Wear PPE signage where mower stored. **See attached HSA guide**

Another example is club equipment especially Ladders or other games equipment such as portable goals. Only for use by 2 or more Adults or Only for use by authorised persons

Sign 6 - Parking at Owners Risk to be placed on property in parking areas

Sign 7 - Entry to the pitch

No Unauthorised entry - players and officials only

Other suggestion is the Players Notice included in appendix

Sign 8 - Dressing rooms

Valuables left at own risk

Please clean up after use

Other relevant notices eg Injury Fund Information

Sign 9 - Bar/ Function room

Relevant signage e.g. Members only. All Guests must be signed in by a member
Warning signs on entrance door if applicable - e.g. - No drinks to be carried onto dancefloor
and / or out of the bar on stairs etc.

Sign 10 - All Weather Facility

Sign 12. Small repeat signs on Property [\(reviewed as per Safety Statement\)](#)

3. Entrance to the playing fields signage

Players and team and Match Officials only beyond this point

In all Hurling training and fixtures a helmet with a face guard must be worn at all times

In all Football training and fixtures a mouthguard must be worn at all times

4. Valuables notice

PERSONAL BELONGINGS - Members are responsible for their own belongings and valuables should not be left unattended on the club Property. **Insert Club name** accepts no responsibility for personal items left on the property

5. Astro Pitch Notice

- NO FOOTBALL BOOTS / STUDS / BLADES PERMITTED
- ONLY RUBBER STUDED ASTROTURF BOOTS OR TRAINERS ALLOWED
- NO SMOKING / CHEWING GUM
- ONLY PLASTIC DRINKS CONTAINERS / NO GLASS CONTAINERS
- NO UNAUTHORISED USE OF THE PITCHES
- ANY PLAYER PARTICIPATES AT THEIR OWN RISK AND IT IS THE RESPONSIBILITY OF EACH PLAYER TO ARRANGE EITHER THEIR OWN INSURANCE COVER OR A TEAM INSURANCE COVER THAT WILL COVER THEM FOR INJURY

6. Use of Gym Rules

- MEMBERS ONLY - all members must complete a fitness induction before using the Gym
- USE THE EQUIPMENT PROPERLY - Misusing equipment will lead to injury / damage the equipment; follow directions / instructions of use. Ask Fitness staff if you require assistance
- AGE RESTRICTION - Only persons 16 and over are permitted to use the Gym Facility
- CLEAN THE MACHINE YOU USE - Please respect other users Carry a towel and clean down equipment after use
- PICK UP AFTER YOURSELF - If you move equipment put it back where it belongs. Place rubbish in the bins provided and remove personal items from the facility
