## **ADDITIONAL INFORMATION**

1. The player seeking transfer must complete this form, sign **in Irish** and then present the transfer form for signature to the Secretary of the **present** and **new** G.A.A. clubs.
2. The Secretary of the Club Executive Committee must sign **in Irish**.
3. Forms provided by Coiste na Mí C.L.G. for this purpose must be used by all players and clubs only.
4. Fully completed transfer requests must be submitted to the Secretary of the Coiste na Mí C.L.G between the 1<sup>st</sup> and 31<sup>st</sup> of January 2024 – except where a player has not played in the last 48 weeks.
5. It is the responsibility of the player or club seeking the transfer to ensure that the form is completed per GAA Rules and relevant Coiste na Mí C.L.G bye-laws.
6. All relevant questions must be answered in full otherwise the transfer, may, at the discretion of Coiste na Mí C.L.G be ruled out of order.
7. Coiste na Mí C.L.G shall delegate consideration of transfers to play applications to the Coiste Rialaithe Comórtais CLG na Mí.  
  
It shall process and decide on all applications for transfers and permission to play within the county as per Rule 6.4 T.O. 2023 and Coiste na Mí C.L.G bye-laws.  
  
It shall be responsible, in the first instance, for making decisions on applications for Transfer Within the County.
8. An appeal against the decision of the Coiste Rialaithe Comórtais CLG na Mí on the transfer application may be made in writing by the aggrieved party to the Coiste Éisteachtaí CLG na Mí within 3 working days (72 hours) of receipt of the notification of the decision as Rule 6.4 T.O. 2023.
